



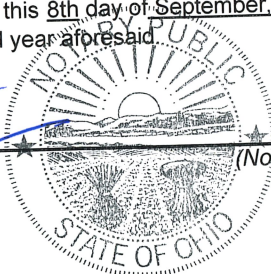

No bid shall be permitted to be withdrawn after 1:00 p.m. EDT, Friday, October 30, 2020 and said bid shall be firm for seventy-five days (75) from date received. The Ohio Revised Code and said bid shall be electronically sent to each participating member Board of Education that will be used for Cooperative School Bus Program evaluations will be electronically sent to each participating member Board of Education that will be used for their desired bids.

Separate and independent bids will be received with respect to the integrated units and will state that the buses when assembled with all participating member school district specifications, all safety regulations and current Ohio minimum standards for school bus chassis and bodies, and with the consent of the director of highway safety pursuant to section 4511.01 of the Ohio Revised Code, shall conform to the provisions of law for the following school bus chassis and bodies:
